**FINANCIAL ACTIVITIES**

**SECRETARY'S REPORT**

**WAGONMASTER'S REPORT** Bob S. reported that we have two campouts left in the season. October 12-14 – Cozy Acres and the MD Fall Samboree October 26-28 with early birds on Thursday, October 25. We also voted to have the additional campout in each year. That means we will have seven campouts in our camping season plus the Fall MD Samboree.

**OLD BUSINESS**

Fundraiser at the Fall Samboree – We will be selling raffle tickets on a “Money Tree” (which Shirley W. will be crafting) with \$100 on it and a “Basket of Cheer” (which Bob and Kath S. have volunteered to put together) which will also cost the chapter \$100.

Donation for the “Goodie Bags” – Hatti B. and Bob C. will be preparing the bottled water for distribution (printing and attaching the “flag” to each bottle). Bob S. will be taking the water to the Samboree since he will be arriving early in the week. The water will be delivered to Bob S. at the Cozy Acres Campout.

Nominations for officers – Vice-president Ken W. was not present at the campout, however, he is heading the nomination committee for chapter officers for 2013. The slate of officers will be presented at the October meeting with voting taking place at the November meeting. New officers will take office in January.

Replacement Banner – Bob C. prepared the layout with the assistance of Hatti B.’s daughter-in-law, to purchase a new Chapter banner. It was presented to the group and got rave reviews. It will be available for all our campouts. The cost was \$53.02 which will be reimbursed to Bob C. We also discussed the purchase of a 2x3 banner because the larger one was extremely heavy to carry at the opening ceremonies at the Samboree. After all the options were given, we decided to get a small vinyl to carry at the Samborees. Even though it won’t be light weight, it will be substantially lighter than the large banner.

Samboree Activities – We voted not to participate in the theme parade at the Samboree. Bob S. is designing a table for presentation (last year we won this contest).
